**CORRIGENDUM** 

INVITATION TO TENDER FOR THE CONSTRUCTION OF ACCESS ROAD NETWORK IN EKITI STATE (ARAGAN THROUGH OGBONTUNTUN COMMUNITY TO OLOBE STREAM, IKORO) AS CORPORATE SOCIAL RESPONSIBILITY (CSR) – PUBLIC NOTICE NO: 4064

### A. INTRODUCTION

The Nigerian Ports Authority hereby wishes to draw the attention of the General Public to our earlier advertisement published as Public Notice No. 4064 in the Guardian and Daily Trust newspapers as well as the Federal Tenders Journal of Monday 16<sup>th</sup> April 2018 and the Authority's website (<a href="https://www.nigerianports.gov.ng">www.nigerianports.gov.ng</a>) in respect of the above-mentioned project.

The project is hereby re-advertised with the following amendments:

### **B. SCOPE OF WORKS**

The scope of works includes but not limited to the construction of an access road approximately 1300 metres long by 5000mm carriageway and involves site clearance, culverts and drains, earthworks and surfacing. Further information is contained in the Standard Bidding Document (SBD).

### C. ELIGIBILITY CRITERIA

Interested companies should submit bound bid documents duly signed, paginated, separated by dividers and arranged in the order outlined hereunder:

# **TENDER REQUIREMENTS**

- 1. Evidence of Certificate of Incorporation with the Corporate Affairs Commission (CAC) including Forms CAC2 and CAC7.
- 2. Evidence of Company Income's Tax Clearance Certificate for the last three (3) years (2015, 2016 & 2017) valid till 31<sup>st</sup> December 2018 with minimum average annual turnover of ₩156 Million.
- 3. Evidence of Company Audited Accounts for the last three (3) years (2015, 2016 & 2017) duly signed by ANAN/ICAN licensed Auditors.
- 4. Evidence of Current Pension Clearance Certificate from National Pension Commission (PENCOM) valid till 31st December 2018.
- 5. Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December 2018.
- 6. Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31<sup>st</sup> December 2018.
- 7. Evidence of registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration report (IRR) expiring on 30/06/2018 or valid Certificate issued by BPP.
- 8. Sworn affidavit disclosing that bidders do not have any Director who has been convicted in any Country for any criminal offence relating to fraud or financial

- impropriety or criminal misrepresentation or falsification of facts relating to any matter;
- 9. Sworn affidavit disclosing whether or not any officer of the relevant committees of the Nigerian Ports Authority (NPA) or Bureau of Public Procurement (BPP) is a former or present director, shareholder or has any pecuniary interest in the bidder and confirm that all information presented in its bid are true and correct in all particulars.
- 10. All documents for submission must be transmitted with a Covering/Forwarding letter under the Company/Firm's Letter Head Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), contact address, telephone (preferably GSM No.), fax and e-mail address. The Letter Head Paper must bear the Names and Nationalities of the Directors of the Company/Firm at the bottom of the page.
- 11. Company profile to include names, qualification and experience of key personnel (copies of relevant academic and professional qualifications of such personnel must be attached) (i.e. COREN, QSRBN, ARCON, CORBON, etc.).
- 12. Evidence of successful completion of **three (3) similar projects** executed in the last **five (5) years** including letters of award, completion certificates, contract agreements, photographs of the projects, etc.
- 13. List of Plants/Equipment with proof of Ownership/Lease.
- 14. Evidence of financial capability/letter of support from a reputable bank.
- 15. For Joint Venture (JV)/Partnership, Memorandum of Understanding (MoU) should be provided. (Items 1-10 are compulsory for each JV partner).

Note: Failure to comply with items 1-10 above will lead to disqualification of the bid.

### D. COLLECTION OF TENDER DOCUMENTS

Interested companies are to collect the Standard Bidding Document (SBD) from the Office of the General Manager, Procurement, 1<sup>st</sup> Floor, Headquarters Building of Nigerian Ports Authority (NPA), 26/28 Marina – Lagos on evidence of payment of a non-refundable fee of #10,000.00 (Ten Thousand Naira) only. The RRR Number can only be generated at the office of the Asst. General Manager Tariff & Billing on the 4<sup>th</sup> Floor before payment in any commercial bank.

Bidders who had paid for the SBD on CSR using the old format (i.e. payment into REMITA account before this re-advertisement) can still utilize those payments.

# **E. SUBMISSION OF TENDER DOCUMENTS**

Prospective bidders are to submit two (2) hard copies each of TECHNICAL and FINANCIAL BIDS with soft copy of financial bid only in MS Excel format (placed in financial bid envelope), packaged SEPARATELY in SEALED ENVELOPES and clearly marked as "Technical Bid" or "Financial Bid" and thereafter put the two sealed envelopes together in a bigger envelope "SECRETARY TO THE TENDERS BOARD, **NIGERIAN** addressed to "INVITATION **AUTHORITY**" marked **TENDER** and clearly TO **FOR** CONSTRUCTION OF ACCESS ROAD NETWORK IN EKITI STATE (ARAGAN THROUGH OGBONTUNTUN COMMUNITY TO OLOBE STREAM, IKORO) AS CORPORATE SOCIAL RESPONSIBILITY (CSR)" specifying PUBLIC NOTICE NO. **4064.** Furthermore, the reverse side of each sealed envelope should have the name and address of the bidder. Thereafter, drop the envelope in the designated Tender Box located on the 1<sup>st</sup> floor of the Headquarters Building of Nigerian Ports Authority at 26/28, Marina Lagos not later than **11.00 am** on **Monday**, **11<sup>th</sup> June 2018**.

The technical bids will be opened **immediately** at the Conference room, 1 Joseph Street, off Marina, Lagos in the presence of bidders or their representatives, while the financial bids will be kept unopened. Please, ensure that you sign the bid submission register in the office of the General Manager, Procurement on the 1<sup>st</sup> floor of the Headquarters Building of Nigerian Ports Authority at 26/28, Marina Lagos adjacent to the Lift Lobby, as the Authority will not be held liable for misplaced or wrongly submitted bids. - 4. The Authority is not bound to pre-qualify any bidder and reserves the right to cancel the Procurement proceedings in the public interest without incurring any liabilities to the bidders in accordance with the provisions of Section 28 of the Public Procurement Act 2007.
- 5. Bidders are advised to visit the site before submitting bids.
