EXPRESSION OF INTEREST FOR THE APPOINTMENT OF A HEALTH CARE FIRM FOR PROSTATE CANCER SCREENING AND AWARENESS CAMPAIGN PROGRAMME

A. INTRODUCTION

Sequel to the non-responsiveness of the bids received in the earlier advertisement of 30th April, 2018, the Authority hereby invites competent and reputable Health Care firms to indicate interest in providing prostate cancer screening and awareness campaign program for all male employees aged forty (40) years and above using the conventional method of Direct Rectal and Prostate Specific Antigen Estimation.

B. SCOPE OF SERVICES

C. EXPRESSION OF INTEREST (EOI) REQUIREMENT

Interested companies should submit bound bid documents duly signed, paginated, separated by dividers and arranged in the order outlined hereunder:

EXPRESSION OF INTEREST (EOI) DOCUMENTS

- 1. Evidence of Certificate of Incorporation with the Corporate Affairs Commission (CAC) including Forms CAC2 and CAC7.
- 2. Evidence of Company Income's Tax Clearance Certificate for the last three (3) years (2015, 2016 & 2017) valid till 31st December 2018.
- 3. Evidence of Company Audited Accounts for the last three (3) years (2015, 2016 & 2017) duly signed by ANAN/ICAN licensed Auditors.
- 4. Evidence of Current Pension Clearance Certificate from National Pension Commission (PENCOM) valid till 31st December 2018.
- 5. Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December 2018.
- 6. Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December 2018.
- 7. Evidence of registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration report (IRR) expiring on 1/1/2019 or valid Certificate issued by BPP.

- 8. Sworn affidavit disclosing that bidders do not have any Director who has been convicted in any Country for any criminal offence relating to fraud or financial impropriety or criminal misrepresentation or falsification of facts relating to any matter;
- 9. Sworn affidavit disclosing whether or not any officer of the relevant committees of the Nigerian Ports Authority (NPA) or Bureau of Public Procurement (BPP) is a former or present director, shareholder or has any pecuniary interest in the bidder and confirm that all information presented in its bid are true and correct in all particulars.
- 10. All documents for submission must be transmitted with a Covering/Forwarding letter under the Company/Firm's Letter Head Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), contact address, telephone (preferably GSM No.), fax and e-mail address. The Letter Head Paper must bear the Names and Nationalities of the Directors of the Company/Firm at the bottom of the page.
- 11. Evidence of financial capability to execute the project by submission of reference letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed.
- 12. Evidence of affiliation with a reputable multinational company with track record in prostrate health.
- 13. Evidence of working agreement or Memorandum of Understanding (MoU) with a registered Urologist of not less than **10 years** post specialty experience with a current practicing license.
- 14. Evidence of two (2) previous prostrate health screening projects successfully executed in the last six (6) years in related government agencies and private companies including letters of awards, contract agreements, completion certificates, etc.
- 15. Company profile to include names, qualification and experience of key personnel (copies of relevant academic and professional qualifications of such personnel must be attached).

Note: Failure to comply with items 1-15 above will lead to disqualification of the bid.
