

COMMENCEMENCES LILYPOND TRUCK PARK

n fulfilment of its commitment of facilitating the Ease of Doing Business at the Nation's seaports, the Management of the Nigerian Ports Authority has yet recorded another landmark with the commencement of Truck Transit Parking (TTP) facility at Lilypond; as part of efforts and commitment to end the gridlock along the Apapa port access roads.

Besides the respite the Truck Transit Park will give to motorist plying the Apapa and Tin Can roads and the general public, the TTP is expected to enhance effective port operations and improved service delivery.

Additionally, the TTP, set up to hold trucks under the call up system for trucks that have businesses to do at the Apapa ports, would give priority to truckers with empties and exports.

The Lilypond TTP facility has the capacity of 1000 units of normal size truck. Besides, the parking space, the facility is to be equipped with critical infrastructures such as operational offices, vehicles, conveniences, illumination and personnel.

The flag off of activities at the facility, which begin in the first instance with the Lilypond TTP, then later the Tin Can Truck Park, was a climax of several successive joint efforts of many tiers of the Federal Government, the Management of the NPA and the stakeholders, at which solutions were proffered to the traffic congestion on the Apapa road.

Lilypond TTP facility was before now the Lilypond Container Terminal, concession to the APMT. The Concession was revoked by the NPA Management to allow for its conversion. This conversion which was done in national interest, is a surest way of substantially reducing the challenges of traffic problems within the Apapa corridor.

Prior to the flag off, the NPA Managing Director, Hadiza Bala Usman had through the Executive Director, Marine & Operations, Dr. Sokonte Davies, embarked upon a sensitisation programme to educate the stakeholders on the benefits of the transit truck park.

Hadiza Bala Usman who explained that the move was part of efforts to end the gridlock, assured stakeholders that the Authority as the Landlord would not fold its arms and allow total breakdown of the system.

She enumerated the plans put in place to ensure the success of the new arrangement. This, include that the incoming task-force should ensure that all trucks are not allowed to park on the bridges, that shipping lines and terminal operators must synergise their operation to ensure the success of the call up system and that security agencies were to remove all categories of truck milling around the Port environment and traffic. The agencies are to ensure that the Tin Can Island to Mile 2 corridor is open for optimal traffic and Port management.

Meanwhile, adding its weight to finding solutions to the problem of the Apapa traffic jam, the Senate Committee on Works has advocated for a multi sector approach between the NPA, the Nigeria Customs Service (NSC) and Nigeria Maritime Administration and Safety Agency (NIMASA) to give waivers to Exporters and Importers so as encourage them to use other Eastern ports, as a way to decongest Ports in the Lagos area.

At an emergency meeting the Committee held with key stakeholders in the nation's Maritime sector, in Lagos recently, its Chairman, Senator Kabiru Gaya said a waiver to exporters and importers would encourage them to patronise other ports outside Lagos, as a way to reduce the pressure on ports within the Lagos area.

Senator Gaya, at the meeting, which was attended by representatives of the NPA, truck drivers associations, Lagos State Traffic Management Authority, Federal Roads Safety Commission and Shippers, stressed the need for cooperation of the various government agencies to make port operation easier and the urgent need to nip in the bud all the identified causes of the gridlock.

Gaya expressed regret that in spite of the various government interventions, "it is a shame to all of us in Nigeria that this gridlock should continue. This is unacceptable".



SUCCESSI NPA CONDUCTS PROMOTIONAL EXA


he Management of Nigerian Ports Authority (NPA) in its determination at improving the morale of its employees for improved service delivery across board, recently conducted promotional examinations for its officers

KIGALI 2019[APRA]:

AU NATIONS CHARGED TO SYNERGIZE THROUGH EFFECTIVE REPORTAGE FOR ECONOMIC GROWTH

edia Practitioners across the continent of Africa have been charged to ensure a more effective and swift reportage of positive information amongst them especially as it concerns issues that would ensure the improved growth and development of the African peoples before the International community with a view to correcting the negative reportage of Africa before the Western world as this would help in the elaborate development of the economic growth of Africa especially its Gross Domestic Product.

These remarks were made by the President of the Republic of Rwanda Paul Kagame, represent by the Country's Minister for Foreign Affairs, Dr. Richard Sezibera at the opening ceremony of the 31st edition of Association of African Public Relations Association Conference [APRA] held in Kigali the Rwandan Capital.

He charged Public Relations Practitioners to come up with effective strategies with which the African Story would be positively told. According to him "Outsiders have told our story, telling it ourselves would change our story".

Kagame affirmed that in view of the shortcomings still faced by the African continent such as famine, poverty, diseases and underdevelopment, the continent is blessed with abundant talents who are vibrant and ready to join hand together for the desired growth which the outside would need to know through effective reportage.

Earlier on, in his opening address, the Chairman of the event and Former President of Ghana John Dramani Mahama charged participants to use the Conference to help gather and discuss the African story which dates back to centuries and must not die.

In addition, "The African Story is linked to a library which must not get burnt. The African story had been neglected by Africans who have embraced the Western story because we allowed them." He charged practitioners to inform "the Western world of stories in Africa such as the girl child education, improved standard of living and 4% to 6% Gross Domestic Product (GDP) growth. We Africans have tongues in our mouths, let us tell our story" he reiterated.

The President of Africa Public Relations Associations (APRA) Mr. Yomi Badejo-Okunsanya called for renewed collaboration with Governments within the continent's potentials since its inception in 1975 in Kenya through the use of Public Relations Practitioners.

As part of preparing Management Staff for the new Vistas and balance reportage through the rejigging of its officers for enhanced professionalism with other Stakeholders, the Authorities of the Nigerian Ports Authority recently sponsored some of its officials and a handful of journalists to this year's Conference held at the Serena Hotel, Kigali, Rwanda.

At the end of the conference which witnessed the attendance of over 40 African nations across Africa, participants were charged on the need to avail themselves of the latest Public Relations Tools which would adequately ensure there is balanced and effective reportage of events in Africa.

ome workplace hazards such as working at heights and operating heavy machinery are well known and are by organization's safety procedures taken care of

However, there are many lesser known hazards lurking in the workplace that can pose serious threat to employees' health and safety. Based on data from Occupational Safety and Health Administration (OSHA) Bureau of Labour Statistics, there are 7 commonly overlooked safety issues.

STRESS

Stress affects workers in every industry, including manufacturing, healthcare, transportation and energy. Long days combined with an increased workload, financial pressures and job instability all add up to tired, frazzled employees.

Stress lower productivity and put workers at risk for physical and mental illness including anxiety, depression, and even suicide. More than 10% of healthcare claims are attributed to stress at work.

DISTRACTIONS

Staying safe depends on the worker's ability to pay attention to their surroundings and anticipate potential hazards. Today's workers have more competing for their attention than ever. Among these distractions, texting and using headphones to listen to music are common contributors to workplace accidents.

POOR ERGONOMICS

Ergonomics is the science of designing the working environment to fit the worker. Without proper ergonomics, tasks like lifting of heavy objects, reaching overhead, performing repetitive tasks, improper sitting on chair, or even working on computer with bad lighting can lead to fatigue and musculoskeletal injuries. According to OSHA, musculoskeletal disorders account for about a third of workers injury and illness cases.

WORKING ALONE

Working alone is common in many industries, from truck drivers to night shift factory workers, home health care nurses, security personnel, and even business travelers. Keeping lone workers safe presents a number of challenges.

Working alone can increase the risk of injury, especially when performing dangerous tasks. If a lone worker is injured, there's no one

around to call for help or provide emergency medical attention. And without other workers present, there is no telling of how long it will take for someone to notice there's a problem.

BULLYING AND HARASSMENT

Bullying and harassment are often considered an HR issue. This can have serious impact on workers' physical and mental health. Research had showed that victims of workplace harassment may developed anxiety, depression, and even post-traumatic stress disorder (PTSD). This had also been linked to increased drug use and, in most serious cases, suicide.

TEMPORARY WORKERS

Approximately 2.8 million workers or about 10% of American Workers are considered temporary workers while Nigeria lacks statistic on numbers of temporary or contract workers

These workers perform dangerous jobs without adequate training on safety practices or job specific hazards. Analysis of millions of workers' compensation claims found that temporary workers are more likely to get hurt on the job than permanent employees.

SAFETY SYSTEMS

Collecting and analyzing safety data, such as incident reports and near miss observations, is an integral part of any safety program. Many organizations lack effective system for reporting and addressing these issues. Without these systems in place, safety personnel miss out on valuable insights that could help prevent injuries and accidents.

For a safe working environment, these commonly overlooked safety issues must be addressed by management and individual to ensure a safer workplace.
