WORLD MARITIME DAY:

NPA JOINS STAKEHOLDERS IN HERALDING FOR PORT SAFETY



he subject of port safety came to the fore recently when the Managing Director of Nigerian Ports Authority (NPA), Dr Abubakar Dantsoho joined other stakeholders in the Maritime Sub-sector to celebrate the 2024 World Maritime Day in Lagos, with the theme "Navigating the Future: Safety First". The event highlighted the importance of shipping safety, security, and the marine environment, aligning with the International Maritime Organisation's (IMO) mission ideals.

Speaking at the event the Hon. Minister of Marine and Blue Economy, Adegboyega Oyetola, represented by the Permanent Secretary of the Ministry, Mr. Olufemi Oloruntola, emphasised the need for investments in upgrading port facilities to ensure both shipping safety and operational efficiency.

"Key among the initiatives of the ministry are digitalisation and automation of port operations to enhance safety, security, and efficiency as well as performance optimisation to reduce costs and increase reliability, and adopt innovative practices that will propel our industry towards sustainable development. "The administration of President Bola

Tinubu is investing heavily in port modernisation to reduce inefficiencies, lower operational costs, and improve safety in our, ports particularly through public-private partnerships (PPP) arrangements."

Earlier in the event, the Managing Director, of Nigerian Ports Authority (NPA) Dr. Abubakar Dantsoho represented by the Executive Director, Engineering and Technical Services Engr. Ibrahim Abba Umar said the Nigerian Ports is at the conclusive stages of the deployment of the Port Community System (PCS.). Noting that automation is the linchpin of port efficiency and when the PCS is concluded, it will set the pace for the

operationalization of the National Single Window Project of the Federal Government. Additionally, an essay competition was held for secondary school students, with winners receiving cash prizes, laptops and plaques at the event.



PLANNING YOUR TIME WISELY

he hallmark of successful time management is being consistently productive each day. Many people use a daily plan to motivate themselves. Having a daily plan and committing to it can help you stay focused on the priorities of that particular day. JIT: The abbreviation for "just in time," which is a way to minimize warehousing costs by having cargo shipped to arrive just in time for its use. This inventory control method depends on extremely reliable transportation.

Labour union: An organization of workers formed to serve members' collective interests with regard to wages and working conditions. The maritime unions within ports can include locals of the larger union, such as the General Longshore Workers; Clerks and Checkers; Sack-sewers, Sweepers, Water boys and Coopers; Dock Loaders and Unloaders of Freight Cars and Barges; Dray Clerks, Weighers and Samplers; plus the Seafarer's International Union; the National Maritime Union; the Marine Engineers' Beneficial Association and the Teamsters. Some laborers don't belong to a union.

Landlord port: At a landlord port, the port authority builds the wharves, which it then rents or leases to a terminal operator (usually a stevedoring company). The operator invests in cargo-handling equipment (forklifts, cranes, etc), hires longshore laborers to operate such lift machinery and negotiates contracts with ocean carriers (steamship services) to handle the unloading and loading of ship cargoes. (See also: operating port.)

LASH: These 900-foot-long ships carry small barges inside the vessel. LASH stands for Lighter Aboard Ship. Just as cargo is transported by barge from the shallower parts of the Mississippi River to the Port of New Orleans for export aboard ocean-going ships, LASH barges are lifted into these unusual ships. Overseas, the ship can discharge clusters of barges in the open waters. Then several towboats will assemble the barges into tows bound for various ports and inland waterways, without the ship having to spend time traveling to each port.

SOUTH AFRICA VISA APPLICATION CHECKLIST

he South African High Commission has provided guidance to help you submit your application. This guidance is available on the following website www.sal.com/southafricanda This form will be used by the staff member who accepts your visa application to record the documents you have submitted with your application.

PLEASE NOTE

- Children below 18 years of age should attach a full birth certificate Parental Consent Affidavit signed and stamped by the Commissioner of oaths and a consent letter if traveling alone or with one parent.
- Children below the age of 1 year do not require a Yellow fever certificate.
- Children below 18 years when the visa is issued should travel with their original full birth. certificate and Parental Consent Affidavit.
- Please ensure that the passport is signed.
- Applicants should submit in person.
- For Group Applications Kindly Provide Copies of supporting Documents for each application.
- Additional Documents might be required by the High Commission.

MANDATORY REQUIREMENTS

- Completed and signed Application Form (81-84 FORM) in black ink only.
- A valid passport with respect to each applicant with at least 2 clear pages and should be valid for at least a period of 1 month from the date of return.
- Non-Refundable Visa fee of USD 36for countries that are not fee exempt Non-Refundable VS Service fee USD 80 to be charged in UGX (collected based on daily forex rate).
- > A photocopy of a valid Yellow Fever Certificate.
- For self-employed applicants, a letter from their business, and certificates of registration.
- Personal and Company 3 months bank statements up to the current date of submission.
- > Bark Letter accompanying the statement, confirming account name, account number, and account balance in the figure and should indicate the Bark email and contact number of the concerned person in the bank.
- > Consent Latter (Permitting The South Africa High Commission to get information from the bank).
- Photocopy of the Biodata page of your current passport.
- Two passport size photographs 45*35mm) not more than 12 months old coloured with white or clear background.
- For foreign nationals, work-study or residence permit valid for at least 1 year and above endorsed in the passport.
- > Signed Introduction letter from employer/school/institution/Organization.
- Signed letter of invitation
- > Letter of introduction from employer organization or school
- Consent letter (applies to only those below 18 years) Copy of parents ID, A full birth certificate, Parental Consent Affidavit Form, Death Certificate if deceased, Hotel Booking and Fight reservations.

are obtained. This is why these classes of medications are not obtained. This is why these class of medications are not obtained over the counter in other climes.

3. Venepuncture which is the process of obtaining blood samples for laboratory tests is best done in the clinic setting for hygiene purposes and for ease of attending to any resultant complications which is a possibility with the procedure. Blood samples are thus not allowed to be collected in the office space.

t the Nigerian Ports Authority clinics, the health and safety of our employees and patients are our priority and of utmost importance. Medical management and treatment guidelines are aimed at the effective and efficient management of patients and align with world best practices and professional ethics with the ultimate aim of achieving the best positive outcomes for the patient.

The need to point out a few necessary guidelines in response to recent occurrences where patients seeking refill of blood pressure and diabetes medications without prior consultation were eventually discovered to have dangerously high blood pressure and raised blood sugar which would have necessitated prescription review by the doctor before a refill. Requesting medications without consults may seem 'convenient' but portends great health risks and predisposes to inadvertent drug misuse.

In furtherance to the above, kindly note the following:

- Patients requesting medication refills, especially for chronic conditions like hypertension and diabetes should endeavour to have documented reviews and checks which are necessary for dosage adjustments and medical documentation, an important strategy for efficient management/treatment.
- For avoidance of drug resistance and treatment failure, antibiotics, antifungals, antimalarial and other chemotherapeutic agents are prescribed after relevant tests and sensitivity results

Calling attention to above guidelines has become necessary to stem a potential rise in drug resistance, treatment failures, avoid medical complications and achieve a healthier work force which is our ultimate goal.

We seek the kind cooperation and understanding of heads of divisions/departments in ensuring adherence to these guidelines as we strive to continuous provision of standard, safe and effective
